**Reason (R) It was during the early medieval period that Ramanuja and Shankaracharya spread the message of Bhakti in Northern India.**

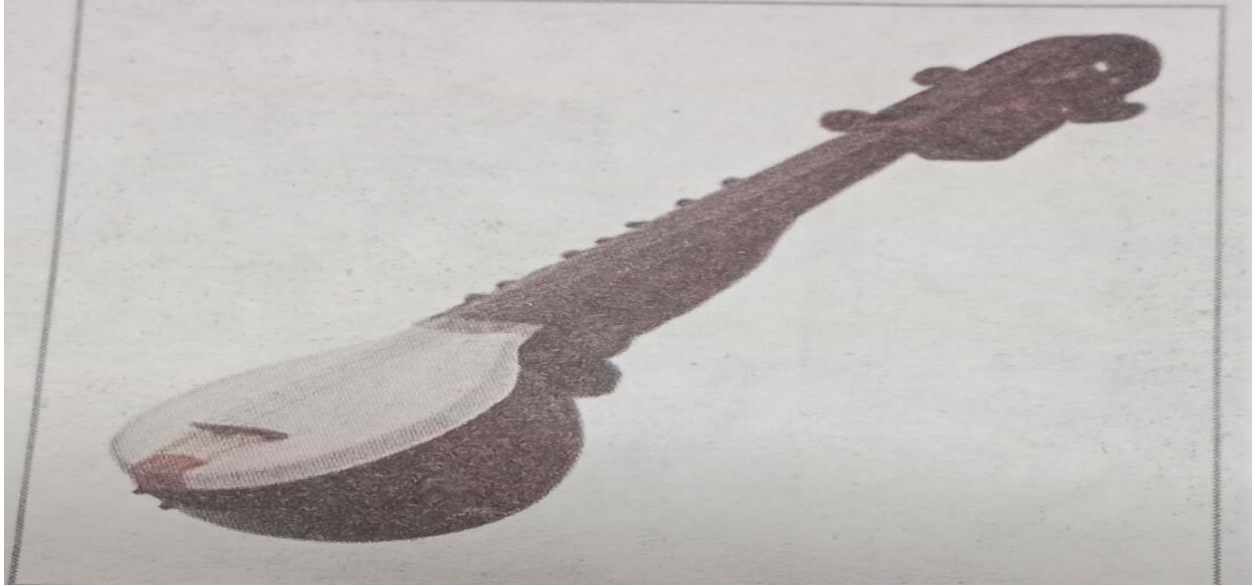
